Under the direct supervision of the Process General Foreman, the candidate will oversee the daily operation of the crushing and conveying functions to ensure all areas are safely operating at their most efficient capacity. This position at times may be physically and mentally demanding and requires critical thinking and sound judgement. The ideal candidate will possess a great work ethic with a drive for improvement.
