MAINTENANCE TECHNICIAN - MILLWRIGHT

Under the direction of the Fixed Supervisor, the Millwright is responsible for maintaining all mechanical planned and unplanned repairs to the equipment. To repair the routine and emergency repairs required of all fixed maintenance equipment. To maintain, with the highest standard of safety across the mine-site. This position will work on a rotational schedule of 12-hour shifts. Responsibilities are noted below which will include but are not limited to:

Main Tasks and Responsibilities:

- Safety of self and others;
- Working with a team to conduct job risk assessments and safe work plans ahead of the task being started and performing work in a safe and well-managed manner;
- Conducting preventative maintenance and servicing of fixed equipment;
- Checking for proper performance and inspecting equipment to detect faults and malfunctions;
- Diagnosing, troubleshooting and determining extent of mechanical problems;
- Rebuilding components and working with manufacturers when necessary;
- Documenting and returning all completed work orders in a timely manner;
- Communicating with Supervisors and coworkers to coordinate work and provide updates; and
- Provide input and work collaboratively with Planners and Schedulers to develop work packages.

Qualifications and Experience:

- Inter-Provincial Trades Certification as a Millwright with 3 to 5 years’ experience in the mining industry repairing and maintaining crushing and fixed equipment;
