Victoria and FNNND Renew and **Update Their CBA**

In June 2021 Victoria Gold and the First Nation of Na-Cho Nyak Dun (FNNND) announced the successful completion of a rigorous round of negotiations to renew and update the parties' Comprehensive Co-operation and Benefits Agreement (CBA). Mark Ayranto, Victoria Gold's COO, said "the co-operation and mutual collaboration between Victoria Gold and FNNND that has flowed from the original CBA signed in October 2011 has been strengthened and renewed. Victoria looks forward to another decade of constructive relationship and benefit with its First Nation partner."

Much has changed since 2011. In the view of both FNNND and Victoria Gold the CBA needed to be updated to keep pace. A primary amendment agreed to by Victoria Gold at the request of FNNND was a revised financial benefits schedule. Victoria Gold accepted that an increase was necessary to provide an even greater level of financial benefit from Victoria Gold mine activities. This change will come into effect when Victoria Gold has the approvals and permits required to extend the mine. "The financial benefit amendment will more than triple the financial benefit payments to be made to FNNND," said Mr. Ayranto.

The FNNND proposed a number of other amendments agreeable to Victoria Gold. These amendments aim to improve and enhance communications, environmental monitoring, cross cultural training, and employment and contracting opportunities for FNNND citizens. The parties also recognized a need for a strengthened relationship between Victoria Gold and the NND Development Corp. All in all, the result is a successful revitalization of a solid relationship between the parties.







PRESIDENT'S MESSAGE

Now, at the onset of winter, I reflect that we were able to socialize again this past spring and summer. In June, I was delighted to host the Eagle Gold Mine Grand Opening Tour after being delayed by two years. In July, we resumed our annual VGCX Golf Tournament to support increased student attendance across the territory. I very much appreciate being able to meet in person again with our suppliers, partners and Yukoners at large.

We are also thankful to resume providing tours at the Eagle Gold Mine and this summer we hosted groups of students, investors, community members and other stakeholders. Visiting the mine in person is a valuable opportunity to understand our operations and processes first hand.

We are glad that community events are also back on-stream: Victoria Gold has renewed our multiyear sponsorships with the Yukon First Nations Hockey Association's Tournament, the Klondike Gold Ruff Charity Run, and the Klondike Road Relay to name a few.

In September we announced exploration results at Eagle and at Raven. The Eagle exploration drilling program confirmed that the Eagle Deposit is open at depth and along strike, which means that the Eagle mine can provide jobs and opportunities further into the future. At Raven, we announced a Maiden Resource Estimate (MRE) of over 1 million ounces of gold. Raven is an additional gold deposit located 15 km east of Eagle and is proving that more gold exists on the Dublin Gulch property.

Once again, thank you Yukoners! It is with your support that we can continue our work and contribute to the community in a meaningful way.


Eagle Extension Project update

The team at Victoria Gold continues to prepare the information required for the **Eagle Extension Project** submission to the Yukon Environmental and Socio-economic Assessment Board (YESAB).

YESAB's new Pre-submission Engagement (PSE) Process for Executive Committee screenings came into effect June 1, 2022. The PSE process brings interested and affected parties together to review project requirements in advance of submitting the detailed proposal and supporting information for assessment. The Eagle Extension Project is subject to the PSE Process. The first step was our submission of a Project Description, which describes the activities and the environmental and socioeconomic setting.

The Project Description is available to be reviewed by interested and affected parties on YESAB's Online Registry (Project No. 2022-0125). Participant comments received during the first comment period of the PSE Process will allow the YESAB to develop a Project Proposal Guideline document that outlines the information requirements for the Project Proposal submission. There will be subsequent comment periods during the PSE Process to provide opportunities for further public input.

Construction and General Operations Update

The summer months at the Eagle Mine were busy with ongoing construction projects. Over the past summer, the construction team successfully installed another 120,000m² of liner beyond the current uppermost lifts of the Heap Leach Facility. This phase of liner will provide stacking capacity for an additional 1 to 2 years. The mine has scheduled earthworks and liner installation at strategic intervals to continue to expand the heap leach facility as required.

At the same time, construction of the Water Treatment Plant is progressing. The building has been erected and mechanical equipment and piping is being installed inside. Commissioning of the plant is planned in the fourth quarter of this year.

Mining at the Eagle Open Pit is currently in Phase 2 and in Phase 3. Phase 1, the initial starter pit, was completed early in 2022. Ore is being mined in Phase 2 and waste stripping is ongoing in Phase 3. This summer, development of the Eagle Pup rock drain continued to support the development of the Eagle Pup Waste Rock Storage Area. The rock drain helps water flow through the waste rock which helps with providing greater stability of the waste rock storage Area is being constructed overtop of the rock drain in controlled lifts.

At the Heap Leach Facility, stacking continues on the current lift for the remainder of the year, and then transition to the next lift in early 2023. Areas of approximately 45m x 45m in size (2,025m2) are placed under leach in regular intervals as ore is stacked.

Environmental Update

Progressive reclamation is a priority for Victoria Gold on the Eagle Gold Project. Victoria Gold performs an annual seeding and erosion control program on exposed slopes to progress mine reclamation and reduce erosion. A directed sediment and erosion control program was developed with the First Nation of Na-Cho Nyak Dun (FNNND) this summer and was implemented from August 22-26. FNNND's Reclamation Coordinator, led several young adults from the community who participated in the on-site program at the Eagle Gold Mine, working alongside Victoria Gold's Environmental department.

The team successfully installed silt fencing, straw bales, and jute mats in target areas along Dublin Gulch to prevent sedimentation in Dublin Gulch and bodies of water downstream. Efforts were also made to revegetate these areas through seeding and willow staking.

Exploration Update

The 2022 Dublin Gulch exploration program represents the largest ever campaign conducted on the Raven and Lynx target areas; the main focus of which is the Raven deposit - the newest, and rapidly developing gold resource on the Dublin Gulch property.

The Exploration Team is excited and encouraged with the release of the Maiden Resource of 1.1 million gold ounces at Raven (See Company News Release Dated Sept 15, 2022). This achievement was the culmination of 4 years of hard work and is a testament to Victoria's team and the successful application of the internally developed Potato Hills Trend district exploration model.



In addition to gaining valuable environmental field experience, the group participated in daily health and safety meetings. The group also had the opportunity to tour and learn about mining operations in the Open Pit and gold processing at the Heap Leach Facility. This educational week wrapped up with a visit to Potato Hills, a traditional hunting and harvesting area for the First Nation.

Exploration efforts commenced in early June 2022 and involved four diamond drills at Raven. Drilling focused on step-outs along strike to the east and west of the previously defined extents of the Raven deposit, as well as testing areas to the south and north of Raven.

This season's exploration program culminated in over 25,000 metres of diamond drilling from 90 holes in Raven and 1,970 metres of drilling from 6 holes in Lynx.

The 2022 Exploration Team is comprised of Victoria Gold geologists, local Mayo employees, including Yukon First Nations members and NND Development Corp. contractors. In addition, support for the Exploration Program including drilling, logistics, materials and goods was sourced primarily from Yukon based companies.

Victoria's Exploration Team's activities will shift over the winter months to the compilation of results from the 2022 program and preparation of updated geologic models for Raven and Lynx. The team looks forward to planning the 2023 exploration programs which will include Nugget, Raven, Lynx, and other targets on the Dublin Gulch property.

Health, Safety & Security

The Health, Safety & Security (HSS) team regularly train to respond to all emergencies at the mine site, and are certified in Surface Mine Rescue.

Skills training include firefighting, rope rescue, hazmat, gas awareness for mining, rescue operations for vehicle extraction, confined spaces, electrical hazards, and advanced first aid techniques to name a few.

Ongoing Standard First Aid courses are delivered to worker at the Eagle Gold Mine to provide them with skills to use at work and at home. Skills training includes CPR, how to use AED, minor wound management, how to control a deadly bleed, what to do when someone is choking, plus other life-saving skills.
