Under the direction of the Senior Maintenance Planner, the E&I Planner is responsible for the planning and scheduling of E&I activities at the Eagle Gold Project. The E&I Planner works closely with Superintendents and Supervisors across all areas. This position will work on a rotational basis. **This position offers a competitive salary between \$117,00 – 130,500, dependent on skills, experience, and qualifications.** Responsibilities are noted below which will include but are not limited to:

Main Tasks and Responsibilities:

- Supports a strong safety culture
- Prepare Work Orders for execution through applying the principles of maintenance planning
- Create 1–2-week advanced schedules for the E&I Supervisors

- Assist in the development and maintaining of the preventative maintenance system
