## **FIXED MAINTENANCE SUPERVISOR**

Under the direction of the Fixed Maintenance General Foreman, the Fixed Maintenance Supervisor is responsible for organizing all mechanical planned and unplanned repairs to the equipment. To supervise the routine, emergency, major component change outs of all fixed maintenance equipment. To supervise, coordinate, lead and monitor all activities with the highest standard of safety across the mine-site. The position is site-based working a 2-week rotational schedule of 12-hour shifts. **This position offers a competitive salary starting between \$129,150 – 143,500** Responsibilities are noted below which will include but are not limited to:

## Main Tasks and Responsibilities:

- Ensure employees are in compliance with all Company policies/procedures and safety regulations;
- Zero environmental non-compliances, accidents and incidents;
- Provide leadership to the fixed maintenance team;
